

# OKLAHOMA COMMUNITY HEALTH CENTERS FACTS & FIGURES



#### What are CHCs?

Community health centers (CHCs), also known as Federally Qualified Health Centers (FQHCs) or health centers, are nonprofit health care providers that deliver comprehensive primary health care services to medically underserved communities including families and individuals in rural areas, low income populations, the uninsured, people with limited English proficiency, and all patients regardless of ability to pay. CHCs offer a host of services like dental, optometry, vision, behavioral health, and substance use disorder services.

CHCs use sliding fee scales based on patients' income, have afterhours coverage, meet extensive performance and accountability requirements, and are governed by patient-majority boards.

CHCs provide integrated primary health care where there is a low ratio of primary care physicians to people. Studies show community health centers save the health system money by providing preventive and primary care services. Many health centers provide dental, behavioral, transportation, case management, and other cost-efficient services to best serve the patients in their communities.






#### Most Oklahomans Live Within 30 Minutes of a CHC

### **Community Health Center Patients by Zip Code**



In 2021, community health centers (CHC) in Oklahoma served 311,306 patients in over 600 zip codes. In seventy zip codes, community health centers served more than 1,000 patients in 2021. The zip code with the most CHC patients was 73505, with 14,718 patients served. Today, 90% of Oklahomans live within a 30-minute drive of a community health center. ### OKLAHOMA COMMUNITY HEALTH CENTERS

A cost-effective solution to Oklahoma's health care needs



Community health centers (CHCs) save money by preventing chronic disease and avoidable hospitalizations. A study in AJPH found Medicaid patients seen by CHCs cost 24% less than other providers.



CHCs produce **cost-savings in the Medicaid program** by coordinating services, integrating care, and averting chronic disease. 3/4 of all children served by Oklahoma CHCs and 1/3 of all CHC patients are covered by Medicaid.



In many communities, CHCs are the largest employers. For every physician employed in a rural community, over \$1.5 million in economic growth is generated. CHCs are helping solve the state's health workforce shortages.




CHCs serve everyone regardless of ability to pay or insurance status. CHCs use sliding fee scales so patients can pay based on their income.

When people without insurance have access to primary care, they are less likely to rack up uncompensated care in the ER.

## Patients Served by OK CHCs

Oklahoma health centers have grown to meet the needs of their communities. In 1998, there were four health center sites in OK serving fewer than 40,000 people.

Today, twenty-two organizations at 150+ sites serve over 310,000 Oklahomans.




### **Access for the Underserved**

1 in 3 patients are Medicaid recipients.

Patients with incomes between 100-200% of the federal poverty level (FPL) pay on a sliding fee scale. Patients with incomes under 100% pay a nominal fee.

Over 88% of patients with known incomes live in households earning less than 200% FPL; 72% made less than 100% FPL.

## **Medicare Cost Savings**

- 2012 Study: 10% increase in primary care spending in the Medicare program would result in a 2% decrease in the total cost for the program over 10 years.
- Patient Care Network of Oklahoma was the only ACO in OK to achieve savings for FY2018.
- OK health centers in the ACO saved Medicare \$2.8+ million in 2018 and \$7.0 million in 2019 PY
- Acuity of the expansion population will mirror Medicare population more closely than the traditional Medicaid population.



## **Medicaid Cost Savings**

2016 Study in AJPH: 13-state Medicaid claims data study found that Medicaid patients served by health centers **saved Medicaid programs 24% per person** on average compared to Medicaid patients served by other providers by achieving:

- 22% fewer specialty care visits;
- 33% lower spending on specialty care; and
- 25% fewer inpatient admissions.


